DIRECTIONS and PARKING:

Judges' Cup will be held in UIC's PE Building, located at 901 W. Roosevelt Rd. Chicago, IL. The building is located on the south side of Roosevelt Rd. between Halsted St. & Morgan St. **PARKING** is located in Lot 5C directly across the street from the PE Bldg. (north side of Roosevelt Rd.) Enter the parking lot from Morgan St. There is a charge for parking. Participants and spectators must park in Lot 5C.



From the NORTH:

Take the Kennedy Expy., pass the Eisenhower (I-290) Expy. Immediately exit at Taylor Street. Go up the ramp and continue going south to Roosevelt Rd. Turn right on Roosevelt Rd.

From the WEST:

Take the Eisenhower Expy to the Dan Ryan (90/94) towards Indiana. Follow the ramp to the Dan Ryan. Immediately exit at Taylor Street. Go up the ramp and continue going south to Roosevelt Rd. Turn right on Roosevelt Rd.

From the SOUTH:

Take the Dan Ryan Expy. Exit at Roosevelt Rd. Turn left on Roosevelt Rd.

From the SOUTHWEST (I-55):

North on I-55 towards Chicago. Take 90/94 (towards Wisconsin). Exit at Roosevelt Rd. Turn left on Roosevelt Rd. The gym is on the left.
